SWDA will provide one scheduled pickup per month, at no charge, to customers with accounts in good standing.

Pickups may consist of Bulky Waste, White Goods, Light Construction and/or Yard Debris Limit of 4 cubic yards per pickup

Bulky Waste

YES - Furniture, Appliances, Mattresses, Carpet, Auto Tires (limit 4 - less than 20" in diameter) YES - Refrigerator, Range, Water Heater, Air Conditioner, Exercise Equipment, & Other Large Appliances, Swing Sets (must be broken down) NO - Fence Wire

Light Construction

YES - From small home DIY repairs & projects NO - C&D waste generated by a contractor

Yard Waste

YES - Grass Clippings & Leaves (must be bagged), Twigs, Limbs, etc.

NO - Tree Trunks or Limbs over 6 inches in

diameter or over 6 feet in length

Waste or Debris generated by a Contractor is not
eligible for pickup!

Billing Policy:

Bills will be mailed out Quarterly (payments are due the first month of your quarter).

Your first bill will be based on the date of your first service pickup provided.

There is no prorated billing.

Failure to receive a statement does not excuse a customer from making timely payments on their account.

Payment Policy:

We accept cash, check, money order, and credit card payments (Visa, Master Card and Discover). Payments may be made online at baldwincountyswda.org after receiving your first bill.

Late Fee Policy:

Payment is due by the last day of the month in which you are billed. If there is any unpaid balance remaining on your account, a late fee of \$10.00 will be added monthly to your balance.

At 90 days past due, this is considered failure to comply with the Solid Waste Disposal Act and will initiate legal action which could lead to criminal prosecution.

The Code of Alabama, 1975, Section 22-27-3, provides for mandatory participation and subscription to garbage service in Baldwin County. Every person, household, business, industry or property owner is liable for the fee for garbage collection services made available. This also prohibits the illegal burning of waste as a means of disposal.

The Code of Alabama, 1975, Section 22-27-4, states that unauthorized dumps shall be prohibited, removed, enjoined, and enforced upon across the state of Alabama.

Returned Check Policy:

A NSF fee of \$30.00 will be added to your account on all returned checks.

Terminating Service Policy: Each customer is responsible for notifuing SWDA

Baldwin County in order to end service and close their account. Your last bill will be based on the date of your last pickup provided.

Upon termination, we will need a forwarding address and the reason in which service should be cancelled. At any point during the cancellation

Your balance must be paid in full at time-of-service termination
